1.0 Opening

1.1 Welcome & Confirmation of Quorum

7.1 Request for Funding – Jeux de Commerce Canada (JDCC) Juliette presented the updated budget and pitch for funding from the SRC. Confirmation of prices for transportation have not been firmed up, as companies were not willing to commit unless transportation was booked.

MOTION: Moved by Sophia, seconded by Sasha, to postpone this for request for funding until the next BSR, and request that they return with a detailed and accurate budget. CARRIED (17-0-1).


MOTION: Moved by Olivia, seconded by Sophia, to return to Open Session. CARRIED (18-0-0).

Jordan announced the decision to the JDCC representatives. Sophia encouraged them to meet with Brandon ahead of time to ensure a solid and complete budget to present.

8.1 Organizational Response to Israel/Palestine Conflict (Sophia & Irma)

Sophia explained that the reason it is on our agenda today is that the issue has been raised by a small group of students. The proposed statement was circulated in advance and it was explained that in





addition to mental health resources, links to organizations and websites for students to educate themselves on the conflict would be attached. Questions were asked about what resources would be included. These resources have not been determined yet. Irma explained that she is involved with the Muslim Student Association, CASA, and she has been active with protesting. Questions included whether Jewish and Christian groups on campus have been consulted, what further action would take place, protests, if the statement would address conflicts in smaller countries that do not have the attention in the media, if the SRC took stances on past conflicts, and concern that members have not consulted with their constituents.

MOTION: Sophia, second by Olivia, to move into Closed Session. CARRIED (18-0-0).

MOTION: Moved by Sasha, seconded by Olivia, to call the vote and vote by secret ballot. CARRIED. (18-0-0).

MOTION: Moved by Sophia, seconded by Irma, to approve the statement circulated in advance and educational resources yet to be determined. FAILED.
