7.1 Proposed Statement Regarding Israel/Palestine Conflict (Irma)

8.1 Board Consultation - Ethnic Diversity Representative Name Change

Irmah explained that she would like to consult with the board about changing the name of Ethnic Diversity Representative. She explained that the term "ethnic" is derogatory and should not be used to refer to people and does not show cultural sensitivity. She proposes the term Diversity and Inclusion Representative. A brief discussion was held and this will be brought forward under Unfinished Business at our next meeting.

MOTION: Taylor, Olivia, to add question period to the agenda. CARRIED (19-0-0).

Irma asked about access to recording. It was clarified that meeting recordings are not to be shared on social media or to target members for how they voted or what they stated during meetings. Once approved by the BSR, BSR minutes are available on our website at busrc.com/minutes-and-reports.

Irma asked for the results of the secret ballots from this meeting and the meeting on November 13 to be released. It was clarified that secret ballot votes are reported without numbers.

Students can self-declare their priority.

In addition, Student Services will host a Mental Health Fair in the SUB Lobby on Wednesday for students impacted.
