



## **2024 SRC Fall Election – Rules and Regulations**

1. In addition to the SRC Fall Elections – Rules and Regulations, please refer to the SRC Operation Policies Section 1 Elections Policy and the SRC Specific Bylaw XX Elections.
2. **Campaigning**
  - a. If you choose to use social media, you must create a new social media handle to promote your campaign. The handles must be approved by the CRO or DRO by the deadline of Monday September 9 at 3 pm. To get it approved, email your handle name to [srcelections@ubishops.ca](mailto:srcelections@ubishops.ca).
  - b. Every post must include **#bishopsvotes**.
  - c. The approved social media you may use to campaign is Instagram and Facebook. No other social media may be used. All social media must be visible to the CRO and DRO.
  - d. Use of the Internet as a campaign tool is expected, however NO campaign material may be distributed using the Bishop's Media (webmail, digital posters, social media, etc.) or by using any SRC Media (website, Facebook pages, SRC mobile application, etc.). This also means that you cannot use the "students" mailing list.
  - e. Absolutely no campaigning is allowed before **8 am on Tuesday September 10** or you have been verified as a candidate, should that not be accomplished by the start time.
3. **Campaign content** – Slanderous remarks and libelous content about any candidate will not be tolerated and will result in disqualification. Racism, sexism, ableism, etc, will result in disqualification. It is expected that all candidates will run a positive campaign. Please review SRC Operating Policies Section 1 Elections Policy 2.0.
4. **Posters**
  - Candidates are allowed to post a maximum of 25 11" x 17" (maximum size) posters on campus at any one time. Due to limited space, a poster of **8.5" x 11" is recommended**.
  - Posters must be stamped with SRC Election stamp by the DRO or CRO.
  - You are allowed a total of 50 stamped posters and only one poster per location.
  - Posters must be hung on the purple Bulletin Boards, with no part of the poster hanging off the vinyl surface.
  - Before placing a poster in a building, please ask staff in that building for their poster policy.
  - Posters may not be placed on doors, windows, or in hallways.
  - Sticky tac must be used – no tape of any type.
  - Extra posters or posters contravening the rules will be removed and may result in sanctions.
  - Candidates must not remove or cover up another candidate's posters.
  - No candidate may deface or destroy another candidate's posters.
  - Posters must be taken down within 24 hours of the end of voting.
  - N.B. Posters in residence require **an additional stamp**, which is administered by the resident life staff, located in Paterson 100, not the front desk.

- It is strongly advised not to put posters up off campus, however if one chooses to do so, the SRC is not responsible for any fines assessed by the Borough of Lennoxville and/or City of Sherbrooke or any other party. Posting signs off-campus in contravention of municipal bylaws will be considered a violation.
  - Posters can be stamped the week of campaigning. The CRO and DRO will have hours set up to stamp posters. The hours will be communicated with the candidates about the certain hours. The deadline for poster stamping will be **Friday September 13**.
  - If you have questions, please ask.
- 4. Campaign Statement and photo** – These are for the voting site and will appear on the ballot.
- PHOTO:** At the mandatory All-Candidates Meeting on Monday September 9 at 1 pm in McGreer 100, your photo will be taken. No other photos will be used. Come prepared to have your picture taken.
- CANDIDATE STATEMENT:** This is your chance to tell voters who you are and why they should vote for you. Please proofread your statement - it will not be edited. Please provide a candidate statement of about 200 words by 12 noon on Friday September 13. **This is a strict deadline. If it is not met, this information will not be posted on the ballot.**
- 5. Violations** – For minor violations of election policies and procedures, you will be issued a warning. For major violations, candidates will be disqualified. Repeated minor violations result in disqualification. The rules include the SRC Specific Bylaw, the Election Policy and any additional rules issued for this election.
- 6. Election Appeals** – If a candidate feels that there has been a violation of election rules, they have the right to file a formal appeal in **writing** with the Secretary General. The Secretary General will issue rulings, as appropriate, and that decision shall be final, subject to appeal to the Elections Appeal Committee.
